Cork County Council and Waterford City and County Council invite you to participate in the first online public consultation for the Dungarvan to Mallow Greenway. The online consultation will include information about the vision for the greenway and some of the key items being considered during the initial feasibility and route options assessment study. The consultation will also provide an opportunity for you to ask questions and give your initial feedback about the greenway.

The project is considering the development of a greenway extending from the existing terminus of the Waterford Greenway in Dungarvan to Mallow. The greenway is envisioned to generally follow the abandoned railway line between these two towns. The project is currently at the initial study area/constraints and route corridor options assessment stage and your feedback will help guide the development of the greenway and the decision-making process.

Seo cuireadh ó Chomhairle Cathrach agus Contae Phort Láirge agus Comhairle Contae Chorcaí duit chun páirt a ghlacadh sa chéad chomhairliúchán poiblí ar líne don Rian Glas ó Dhún Garbhán go Mala. Áireofar sa chomhairliúchán ar líne faisnéis maidir leis an bhfís don rian glas agus cuid de phríomh-earraí faoi chaibidil le linn staidéir tosaigh ar indéantacht agus staidéar measúnaithe ar roghanna bealaigh. Tabharfaidh an comhairliúchán deis duit freisin chun ceisteanna a chur agus d'aiseolas tosaigh a thabhairt maidir leis an rian glas.

Tá an tionscadal ag plé le forbairt riain ghlais a théann ó chríoch reatha Riain Ghlais na nDéise i nDún Garbhán go dtí Mala.
